A) Once you have finalised the details of your wedding, we will arrange an appointment for you to make your final payment which is due one week before your wedding. All our rooms are perfectly suited to accommodate 2 adult guests - additional sleepers are charged at an extra cost £15.00 per person \*We have a limited number of family, twin, accessible & ground floor rooms

Getting Ready with us?

All of our bedrooms recommended for Wedding couples are perfectly suited for 2 adult sleepers & although they are doubles, can comfortably accommodate 2 single put up camp beds for children.

Our Recommendations;

- If you are planning to stay with us the night before, we ask that you carefully consider the size of the wedding party that you have invited to get ready at the Hotel (including photographers, makeup artists and hairdressers) for parties of 4 adults or more, we would recommend booking an additional room.
- To keep the morning of your Wedding as stress free as possible, we would strongly recommend extending your complimentary reservation (for the night of) to the night before Housekeeping will complete a full clean once you depart for your Civil Ceremony and you will simply hold onto the key.
- Check-out for all guests is 11:00am & check-in is from 2:00pm. Please note both early check-in (from 12:00pm) & late check-out (up to 1:00pm) incur a small charge and are subject to availability. To ensure you and your guests are as prepared as possible for your special day, we ask that you take your chosen Civil Ceremony time into consideration with the above timings.

### **Booking Fee**

An initial fee of £500.00 confirms your booking. Please note that should you cancel your Wedding, the booking fee is non-refundable. In the unlikely event that your Wedding is cancelled by us, your booking fee will be returned. Receipt of your booking fee indicates an absolute acceptance of our terms and conditions.

#### **Cancellations**

If you decide to cancel your booking, the following cancellation charges will apply in addition to the loss of your initial booking fee of £500.00. The booking value of your Wedding will be calculated on the number of your estimated guests. We will take the minimum number in accordance with your chosen wedding package, as detailed on your wedding agreement.

The cancellation charges will include an average drinks spend figure (calculated per head) for the number of guests that would be in attendance during the course of your Wedding. This is in addition to your chosen drinks package. Any accommodation included in your package or added to your main account will also be included in the charges.

Approximately 6 weeks prior to your Wedding, you will be invited to the Hotel to discuss the final details. After that meeting, we will send you a copy of the details, along with a Pro-forma invoice. In your final details meeting, you will make an appointment to pay the final balance which is due no later than 1 week prior to your Wedding. Please note, there are no reductions for less guests than the minimum number, therefore payments for guest no shows or a decrease in numbers are non-refundable. Additional guests will be charged at an extra cost. The cost for additional guests was confirmed to you on booking and detailed on your Wedding Agreement.
